ORDINANCE NUMBER #06-11-ORD-03

AN ORDINANCE FOR THE REQUIREMENT OF OUTDOOR BURNING PERMITS IN THE TOWN OF OSCEOLA .

NOW THEREFORE The Town Board of Supervisors of the Town of Osceola does ordain as follows:

SECTION ONE: PERMIT REQUIRED: PURPOSE. Every person, pursuant to W.S.A. s. 60.555 and other provisions as they may apply and this chapter, in the Town of Osceola shall seek and obtain a fire safety BURNING PERMIT from the Town of Osceola, unless exempt by sections, for any outdoor fire to be ignited in the Town of Osceola. All requirements of this section are for protecting and promoting the health, safety and welfare of the residents of the town.

SECTION TWO: APPLICATION PROCESS.

- A. The application and permit shall designate a single area subject to the burning permit, and the permit shall be issued only for the designated single property. Any permit issued under this section is neither transferable nor assignable, either as to person or as to location. No person shall be issued a burning permit in the Town of Osceola who has failed to properly and fully complete and submit to the Clerk/Treasurer of the Town of Osceola the application form.
- B. The application shall include but not be limited to:
 1. The name of the applicant.
 2. The address of the applicant.
 3. The telephone number of the applicant.
 4. The actual location of the proposed burning area. (A separate permit is required for each different burn location.)

SECTION THREE: EXEMPTIONS. The following are exempt from this permit requirement:

- A. Persons who burn materials in a stove, furnace or incinerator inside a building.
- B. Persons who burn charcoal or other combustible materials for domestic cooking outdoors at their residence or who burn charcoal or other combustible materials for domestic cooking outdoors in public parks. This exemption does not apply upon a declared public fire emergency by the State Department of Natural Resources (DNR).
- C. Persons who burn in burning barrel. This exemption does not apply upon a declared public fire emergency by the State DNR.
- D. In an emergency, fires used to warm the person or to cook food.
- E. Fires set by the Fire Department for training purposes.
- F. Persons who burn in an outdoor furnace
- G. Camp Fires, used for recreational purposes, of not more than 4 feet in diameter.

SECTION FOUR: ISSUANCE OR PERMIT.

- A. A permit shall be issued for the permitted use. The permit shall be issued by the Clerk/Treasurer for the Town of Osceola prior to any person igniting a fire in the Town of Osceola. In addition to receiving the permit, the permit holder must follow the procedures as outlined in Section Five each time he/she wishes to ignite a fire.
- B. There are no daily permits issued. Each resident wishing to burn within the Town of Osceola must obtain a new permit each calendar year. The permit expires on December 31st of the year issued.

SECTION FIVE: NOTICE OF INTENT TO BURN.

- A. On the day the permit holder wishes to burn. The permit holder must call the Polk County Sheriff's Department at **715-485-8300**. The permit holder will be asked his/her name, the location of the burn and telephone number. The permit holder may then burn.
- B. The permit holder must use this procedure each day the permit holder wishes to burn. The permit holder must not leave fires burning unattended.
- C. If there is burning ban set by the Fire Chief at the time the permit holder calls, the Polk County Sheriffs Department will advise that burning will not be allowed until the ban is lifted.

SECTION SIX: REVOCATION OF PERMIT. The Town Board or Fire Chief of the Town of Osceola may revoke a burning permit, and no person shall be issued or reissued a burning permit in the Town of Osceola if the applicant:

- A. Fails to establish adequate fire protection and fire prevention activities at the requested or permitted burning location when established by the Town of Osceola as a condition to the permit.
- B. Fails to install or maintain adequate fire safety equipment during the requested or permitted use when established by the Town of Osceola as a condition of the permit.
- C. Fails to prevent burning activities that are not authorized by the permit of the Town of Osceola at the requested or permitted burning location.
- D. Fails to prevent at or near the requested or permitted burning location any burning activities larger than four feet in diameter within 15 feet of any fence or property line.
- E. Fails to allow physical access to the requested or permitted burning area location by the Fire Chief or designee for inspection purposes upon prior notice.

SECTION SEVEN: GENERAL RESTRICTIONS.

- A. The Town of Osceola prohibits any person from the igniting any fires outdoors in the Town of Osceola upon days declared emergency fire days by the Fire Department or the State of Wisconsin Department of Natural Resources.
- B. The Town of Osceola prohibits any person from igniting of any fires indoors in the Town of Osceola except in a stove, furnace or incinerator.
- C. A permittee shall report to emergency services any fire in the Town of Osceola where the fire is out of control.
- D. The permit holder is responsible for the fire at all times.
- E. The permit holder may ignite and maintain only one fire at a time.

SECTION EIGHT: VIOLATIONS AND PENALTIES; FEES.

- A. Any person violating any of the provisions of this ordinance or knowingly aiding or abetting another in the violation thereof shall, upon conviction, pay a forfeiture as set by the town Board of not less than \$25 nor more than \$500 per incident and the costs and attorney fees in prosecution, with each day in violation of the ordinance constituting a separate offense subject to the provisions of Subsection D of this section.
- B. If a member of the fire Department or Town Board finds a resident burning without a permit, the resident will be required to extinguish the fire until a permit has been obtained following the procedures as outlined in Section Two.
- C. If the Fire Department is called to any fire, the resident may be charged for the cost of the fire as determined by the Fire Chief and Dresser-Osceola-Garfield Fire Association Board.

D. Fees. There shall be no fee for the permit.

The administration rules of the State of Wisconsin and DNR Air Management and Solid Waste Management Programs **prohibit anyone from burning any of the following materials under any conditions:**

- Wet, combustible rubbish, such as wet cardboard or paper.
- Oily substances, such as oily or greasy rags, oil filters, etc.
- Asphalt, such as asphalt shingles or tar paper.
- Plastics of any kind, including plastic bottles and plastic bags.
- Wood products, treated or painted.

Instructions to Burn:

- Each day you plan to burn, call the Dresser-Osceola-Fire Department's answering machine to determine if a burning ban is in effect. Call **755-2945** or **268-6806**.
- Each day you plan to burn, call the Polk County Sheriffs Department at **485-8300** and inform them.
- You will be asked your name, address and phone number at the actual Burn Location.
- If approved, you may then burn. If there is burning ban set by the Fire Chief at that time, the Polk County Sheriffs Department will advise that burning will not be allowed until the ban is lifted.
- **Permit holder may ignite and maintain only one fire at a time. It is prohibited to leave the fire burning unattended.**

Restrictions:

I hereby agree to use all possible care in igniting fires under this permit and to be responsible for all damage done by such fires. I also agree to abide by all Wisconsin State regulations and the Town's Burning Ordinance. I understand this permit will be revoked upon violation of its restrictions. I further understand that if the Fire Department is called to a fire at the Burn Location, permitted or not, I may be responsible to pay all costs incurred for the fire call as determined by the Fire Chief and the Dresser-Osceola-Garfield Fire Board.
