Please be kindly advised our firm has been retained to review a number of Township matters.

With this in mind, please consider this an open records request brought under Wis. Stat. § 19.35(1), Wisconsin's Open Records Laws. Please know I hereby formally demand the Township provide me with a copy of any and all documents, written materials, emails, electronic transmissions, text messages, photographs and any and all written materials submitted by citizens to either your office or members of the Town Board or Town Planning Commission regarding Kraemer Mining & Materials in any fashion.

Our request includes documents from this year, as well as 2008. Since our request includes emails, please know the Attorney General has determined even if emails are sent to a private account, but reference a government issue, like Kraemer Mining & Materials, and are sent to an individual who represents the Town, such as your office or a Town Board or Planning Commission member, such emails are subject to our Open Records Request.

Please also provide a copy of any and all written communications, emails, text messages, photographs, faxes, reports, memos and any and all other written materials held by Town Board members or your office in regard to Kraemer Mining & Materials and the subject of mining in general. Please know this request includes documents for this year, as well as 2008. Please know documents submitted by Kraemer are exempt from this request.
