## Lower Speed Limit on 120<sup>th</sup> Avenue, 210<sup>th</sup> Street and 90<sup>th</sup> Avenue from 55 MPH to 45 MPH

### Ordinance # 18-07-06

- A. The Town Board of Supervisors have inspected and investigated the existing driving conditions and existing speed limit on 120<sup>th</sup> Avenue from 108<sup>th</sup> Street (northern town line to 210<sup>th</sup> Street) and 210<sup>th</sup> Street (South of Poplar Lake to the Rod & Gun Club) and 90<sup>th</sup> Avenue (Rod & Gun club to 200<sup>th</sup> Street). A traffic count and speed analysis was completed.
- B. The Town of Osceola, upon the basis of this inspection and investigation, has determined that the existing 55 mph speed limit on this portion of Town roads is greater than is reasonable or safe under the current conditions found to exist and the speed of vehicles on this portion of Town road is greater than is reasonable and prudent.
- C. Accordingly, the Town of Osceola wishes to exercise its authority under Wisconsin Statutes and declare that the official speed limit be changed.

NOW THEREFORE, pursuant to Wis. Stat. 349.11 and 60.22, The Town Board of Supervisors of the Town of Osceola, Polk County, Wisconsin, do ordain as follows:


*Section 1. Reduction in Speed Limit.* The official speed limit on 120<sup>th</sup> Avenue from 108<sup>th</sup> Street (northern town line to 210<sup>th</sup> Street) and 210<sup>th</sup> Street (South of Poplar Lake to the Rod & Gun Club) and 90<sup>th</sup> Avenue (Rod & Gun club to 200<sup>th</sup> Street) shall be lowered to 45 mph. This speed limit is determined and declared to be reasonable and to further the public health, safety and welfare. Map is attached.

*Section 2. Erection of Signs and Remedies.* The Town's Public Works Supervisor shall erect appropriate signs giving notice of the reduced speed limit specified in Section 1 above. When such signs have been erected and are in place, the new speed limit shall be effective. Any person who violates the new 45 mph speed limit on 120<sup>th</sup> Avenue from 108<sup>th</sup> Street (northern town line to 210<sup>th</sup> Street) and 210<sup>th</sup> Street (South of Poplar Lake to the Rod & Gun Club) and 90<sup>th</sup> Avenue (Rod & Gun club to 200<sup>th</sup> Street) shall be subject to the applicable remedies and forfeitures provided in state law and/or Chapter 15 Vehicles and Traffic in the Town's Code of Ordinances.

*Section 3. Effective Date of Ordinance.* This ordinance shall take effect the day after passage and posting or publication pursuant to law.
