

# TOWN OF OSCEOLA TAX INFORMATION

**A Reminder of the Snow and Debris Removal from Public Roads and Road Right of Ways Ordinance is on the reverse side of this notice.**

**DOG LICENSING** Dog licenses are required in the Town of Osceola. The 2023 Dog License Application is enclosed, licenses must be obtained prior to April 1, 2023. Dog licenses are \$10.00 for spayed and neutered dogs and \$15.00 for non-spayed and non-neutered dogs.

**LOTTERY CREDIT** If this tax residence is your primary residence and you have resided there since January 1, 2022 (or before) and there is **NOT** a lottery credit deduction on your tax bill, call the Town Office at (715)755-3060, ext. 2 to get forms in order to receive this credit. PLEASE DO NOT WAIT UNTIL THE LAST MINUTE TO APPLY FOR THIS LOTTERY CREDIT.

## **CONVENIENT WAYS TO PAY YOUR TAXES**

### **U.S. MAIL**

- For income tax purposes, any end-of-month tax payments received after December 31 but "**postmarked**" by December 31, 2022, will be receipted "December 31, 2022."

### **24-HOUR DROP OFF**

- A mail drop slot is located inside the Town Hall entry foyer.
