**RESOLUTION OF TOWN ELECTORS TO ADOPT THE TOTAL TOWN TAX LEVY
AT SPECIAL TOWN MEETING OF TOWN ELECTORS**

**TOWN OF OSCEOLA, POLK COUNTY
RESOLUTION 22-11-01**

WHEREAS, s.60.10(1)(a) of Wis. Statutes authorizes the town electors of a town to adopt the town levy at a town meeting of the electors; and

WHEREAS, a special Town meeting of the Town of Osceola electors has been called and properly noticed to approve the 2022 total Town tax levy (to be collected in 2023), pursuant to Wis. Stat. s. 60.10(1)(a); and;

WHEREAS, the levy authorized by the electors in 2022 was \$817,368. The 2.197%* increase in the Town's 2022 levy is due to the net new construction percentage increase (\$17,956) and is allowed pursuant to Section 66.0602(2) of Wisconsin Statutes, thus increasing the 2023 total levy to \$835,324*.


SO THEREFORE BE IT RESOLVED by a majority vote of the eligible electors duly assembled and voting on the 14th day of November, 2022 at the special Town meeting does hereby adopt the Town of Osceola, Polk County, Wisconsin, total Town tax levy for 2022 (to be collected in 2023) in the amount of \$835,324*.

The Town clerk shall properly post this resolution as required by law under s. 60.80(1)(a) of Wis. Statutes within 30 days of adoption.


