- 1) This permit authorizes movement only on Town of Osceola roadways. Permission for movement along all other highways and roadways must be obtained from said owners. Refer to attached directory and map
- 2) House moving on Town roadways shall not be permitted after daylight hours or on weekends. All other applicants are permitted movement on weekends but must have appropriate lighting after daylight hours.
- 3) Applicant is responsible to verify vertical clearances.
- 4) Applicant shall give adequate notice to owners of overhead utilities which may be affected by the transportation under this permit.
- 5) Applicant shall comply with appropriate state, federal and local laws and regulations.
- 6) Applicant is responsible for any damage to Town of Osceola roadways pursuant to §86.02. A pre-trip and post-trip inspection will be performed.
- 7) Provide a map and / or specify the route

Acceptance of Conditions: I, the applicant, have read and fully understand the requirements and conditions of this permit. I understand this permit must be carried in the vehicle to which it applies and must have the permit available for inspection by any police officer, representative of issuing authority, or person in charge of the maintenance of the road being used. If granted a permit, I will comply with the terms and conditions which apply.
